4. **Damage and Soiling.** I accept full responsibility for all damages and/or soiling caused by my pet during my stay. I understand that the cost of repair, replacement or additional cleaning requirements beyond normal deep cleaning will be charged. Hotel terry or linen used in any way for pet services will be charged at the full replacement cost.

5. **Unattended Pets.** I understand that my pet may not be left unattended at any time in my hotel room.

6. **Leash Requirement.** I understand my pet must always be kept on a leash when outside my guest room. A pet not on a leash (under positive control) may be removed from the property without liability on the part of Hotel Del Monte. I will assume all costs for such removal.
