Initial each policy below to acknowledge and comply.

1. _____ **Pet Fee.** I agree to pay the nightly pet fee of \$1.00 for each dog. This fee is additional to the nightly site rate.
2. _____ **Pet Identification.** Domesticated dogs and domesticated cats weighing up to 50 pounds each are welcome. Unauthorized dog breeds are Pit Bulls, American Staffordshire Bull Terriers, English Staffordshire Bull Terriers, Rottweilers, Presa Canarios, Dobermans, Pinschers, Chows, Wolf Hybrids, or any mix of the aforementioned breeds.
3. _____ **Pet Relief & Pet.** I understand that I am required immediately to clean up after my pet and dispose of all pet excrement in an appropriate outside trash receptacle. I will respect the sites of others and the golf course regarding my pet's relief.
4. _____ **Damages.** I accept full responsibility for all damages to Naval Support Activity Monterey property caused by my pet during my stay. I understand that the cost of repair and replacement will be charged.
5. _____ **Leash Requirements.** I understand that my pet will always be on a leash (under positive control) when outside. If I tether my pet at my site, I will ensure that the tether is short enough to prevent my pet from accessing adjacent RV sites or the main road. I will not tether my pet to any picnic areas or trees. I understand that my pet may not be left unattended when outside. My pet will be confined inside when I am away.
6. _____ **Restricted Locations & Pet Walking.** I understand that my pet is restricted from the bathrooms, showers, and laundry room. I also understand that my pet may be walked in the campground and surrounding areas, but not on the grounds of the golf course or on the golf course paths.
7. _____ **Immunization & Identification Records.** I certify that my pet's immunization and vaccination records are accurate and up-to-date at time of check-in.
8. _____ **Noisy or Disruptive Pet.** I understand that should my pet pose disruptions to other guests, Monterey Pines RV Park reserves the right to discontinue the lodging of my pet.
9. _____ **Pet Limit.** No more than two pets will occupy my site at any time.
10. _____ **Kennels & Personal Fencing.** I understand that outdoor kennels and personal fencing are not allowed.

I agree with Monterey Pines RV Park's pet policies, and to indemnify Monterey Pines RV Park for any injuries, damages, or loss of revenue to the park or a third party caused by my pet. As the pet's owner/handler, I am responsible for any liability arising from the actions of my pet.
